Warranty Coverage

This warranty is expressly limited to Truflo Air Movement Ltd's products purchased by the original consumer. Truflo Air Movement Ltd warrants each Product against defects in material and workmanship under normal use and service conditions for a period of one (1) year (the "Warranty Period"), starting on the date of purchase of the Product. Truflo Air Movement Ltd's sole obligation under this limited warranty shall be, at its sole discretion, to repair or replace its Product. Repair or replacement under the terms of this limited warranty does not extend or renew the Warranty Period. This limited warranty only extends to the original purchaser of the Product.

Warranty Exclusions

This limited warranty does not cover routine maintenance and also does not cover performance issues:

- a) Caused by normal wear and tear;
- b) Caused by improper installation, or unreasonable or unintended use of the Product;
- c) Which occur after the expiration of the Warranty Period;
- d) Caused by wilful damage, misuse, abuse, accidents, neglect, absence of scheduled maintenance, acts of God, vandalism, flood, fire or any other occurrences beyond the control of Truflo Air Movement Ltd;
- e) Related to any components or parts not supplied by Truflo Air Movement Ltd.
